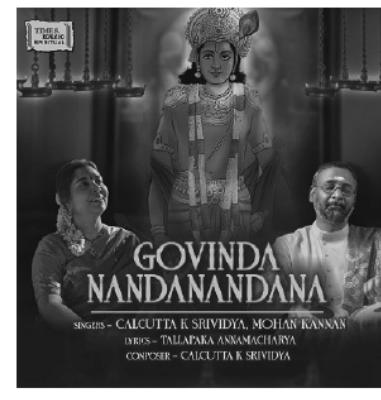
Calcutta Srividya launches bhajan album 'Govinda Nandanandana'
